What is the Disability Rights Commission?

The Disability Rights Commission wants to stop discrimination against disabled people.




Discrimination

This means treating someone worse than other people for some reason.

We tell people about the law. The Disability Discrimination Act is a law that says disabled people must be treated fairly.

We work with disabled people to help them stand up for their rights.



People use websites to do lots of things.

You can use websites to find out what is going on.



And you can use websites to buy things. For example, some people use websites to book their holiday.

Everybody should be able to use websites.

The Disability Rights Commission says that all websites should be **accessible** for disabled people.

Accessible: this means easy to use.

We wanted to find out more about the problems disabled people have with websites. So we held a **Formal Investigation** into websites.



Formal Investigation: this is when the Disability Rights Commission looks at what needs doing so that disabled people are treated fairly.

We looked at 1,000 websites. We also asked disabled people what they thought.

We found out that most websites are not accessible for disabled people.

For example: if a website is accessible, a blind person can listen to the words.




But if a website is not accessible for blind people, the words will not make sense.

Websites are often hard to understand for many people.



The Disability Rights Commission knows it is good for many people if websites have Easy Read pages.

Easy Read pages should have:



Big writing



Pictures

Sound – so that you can listen to the words.

It must also be easy to find the page you want.



The Disability Rights Commission says that the Government should do more to help disabled people use websites.

We also say that **website designers** should talk to disabled people.

Website designer: this means someone who helps to build a website.



They should do this before they build a new website.

They need to find out what disabled people want.

If they do this, they will make websites that are easy for everyone to use.
